

NOTICE OF DELINQUENT TAXES ON REAL PROPERTY IN DOUGLAS COUNTY, NEVADA FOR FISCAL YEAR 2022-2023

The following is a list of real properties on which all or a portion of the current fiscal year taxes remained delinquent as of May 05, 2023. The notice includes the parcel number, the name of the owner of record, and the amount of taxes, penalties, interest, and costs due.

If the amount due is not paid by 5:00 p.m. on Monday, June 5, 2023 (the first Monday in June), a certificate will be issued authorizing the county treasurer, as trustee for the state and county, to hold each property, subject to redemption within 2 years after the date of the certificate. Redemption may be made by payment of the taxes and accruing taxes, penalties and costs, together with interest on the taxes at an annual rate of 10 percent, assessed monthly. Such redemption may be made in accordance with the provisions of Chapter 21 of NRS in regard to real property
