


## 2020 Mail Ballot Primary Election - Important Dates

<b>4/24/2020</b>	Military and overseas ballots delivered.
<b>4/30/2020</b>	Mail ballots mailed to active voters.
<b>5/12/2020</b>	Deadline to register to vote by mail or in-person. Applications postmarked by 5/12/2020 will be accepted.
<b>5/13/2020- 5/21/2020</b>	Extended online registration for voters with Nevada DL/ID. <ul style="list-style-type: none"> <li>• Voters registering during this period will receive a mail ballot.</li> </ul>
<b>5/22/2020- 6/4/2020</b>	Same Day Registration for voters with Nevada DL/ID <ul style="list-style-type: none"> <li>• New Douglas County voters registering during this period must appear in-person and present a valid and current Nevada DL/ID to vote a provisional ballot.</li> <li>• Existing Douglas County voters that update their registration record (name, party, address) during this period must appear in-person, present a Nevada DL/ID, and request a replacement ballot.</li> </ul>
<b>5/23/2020- 06/5/2020</b>	Early Voting Period @ Historic Courthouse- 1616 8 <sup>th</sup> St, Minden. Early voting activities are limited to: <ul style="list-style-type: none"> <li>• Same Day Registrations;</li> <li>• Replacement ballot pick-ups; and</li> <li>• In-person delivery of mail ballots.</li> </ul> 
<b>6/02/2020</b>	Last day replacement ballots will be mailed.
<b>6/03/2020-6/08/2020</b>	Replacement ballots must be picked up during this period.
<b>06/09/2020</b>	<p>Primary Election Vote Center @ Historic Courthouse, 1616 8<sup>th</sup> St., Minden <b>7am-7pm</b> <b>Vote Center activities are limited to:</b></p> <ul style="list-style-type: none"> <li>• <b>Same Day Registrations</b></li> <li>• <b>Replacement ballot pick-ups; and</b></li> <li>• <b>In-person delivery of mail ballot</b></li> </ul> <p>Ballots returned via USPS must be postmarked by this day and received by the Clerk's office by the seventh day after the election to be counted.</p>
<b>6/10/2020- 6/12/2020</b>	Provisional ballot cure period. <ul style="list-style-type: none"> <li>• Identification and/or proof of residency may be provided during this period to ensure the counting of deficient provisional ballots.</li> </ul>
<b>6/10/2020- 6/16/2020</b>	<ul style="list-style-type: none"> <li>• Mail ballots received during this period, postmarked by Election Day, will be processed and counted.</li> <li>• Affirmations with identification for discrepant ballots may be provided during this period to ensure the counting of those mail ballots.</li> </ul>
<b>6/17/2020-6/18/2020</b>	Final verification of Same Day Registration provisional ballots.
<b>6/19/2020</b>	Canvass of Votes- Special Board Meeting to Certify Election Results
